Leaf Pickup Program

Ward 1: Nov 5-13 Ward 2: Nov 14-21

One leaf pickup is available to all residents within the city limits of St. Clair. To have leaves picked up, residents must call City Hall at 636-629-0333 by Friday, November 2nd at 4:30pm. Leaves will only be picked up at addresses that have called City Hall to be placed on the leaf pickup list.

Please place your leaf pile within 5 feet of the street but not in the ditch or around drainage inlets. Please also keep an area of at least 30 feet from the leaf pile clear of all obstacles so that our vacuum truck access the leaf pile. may Remember that sticks and other debris can clog the vacuum truck so be mindful to keep large sticks, twigs, vines, etc. out of the leaf pile.

We appreciate your cooperation and we look forward to picking up your leaves! Please call City Hall if you have any questions.

CHANGES ARE COMING TO THE FALL CLEAN-UP


Thursday, November 1 - Saturday, November 3, 2018 (8:00am-4:00pm)

For many years, the City of St. Clair has held both spring and fall cleanups designed to help residents and property owners in St. Clair clean up and dispose of excess trash and bulk items. The city will have dumpsters available for city residents to dispose of large items. This past spring, our clean-up brought in people from across the county dropping off trash or rummaging through the trash containers, and some even dumped their items on the ground.

In an effort to better serve the citizens and property owners of the City of St. Clair, we will be making some changes to how the clean-ups will operate. The following steps will be taken to help curb some of the illegal dumping and misuse of the clean-up:

- 1. All persons dropping off items at the clean-up must be a resident or property owner in the city limits of St. Clair.
- 2. Upon arrival at the clean-up, each person must present both a valid ID and a utility bill as proof of residency or ownership.
- 3. Staff will be present to verify these documents and verify that what is being dumped is allowed.
- Cameras are being installed to monitor the property any illegal dumping will be prosecuted under the law.
- 5. Dumping will be allowed until 4pm. Ensure you arrive in time to complete the dump by 4pm.
- 6. No one will be allowed to rummage through the dumpsters to pick items out, nor will they be allowed on the property to do the same.
- 7. The dumpsters will be at the City Maintenance Shed, located at 530 Park Avenue.
- 8. As always, tires, batteries, paint, televisions, electronics, and chemicals will not be accepted.

The presence of items not accepted for dumping or failure to provide both the ID and proof of residency will result in the load being rejected!

Recreational Fires in St. Clair are permitted! There are just a few rules to keep the city and its residents safe when lighting a fire:

- 1. DO NOT BURN TRASH—only wood is permissible for burning.
- 2. Fire must be no larger than three feet max in diameter and two feet max in height.
- 3. You can have no more than two fires at a time.
- 4. Do not burn if winds exceed 15mph.
- 5. Always have a hose or fire extinguisher nearby for emergencies.
- 6. Stay safe and have fun enjoying smores!

DID YOU P KNOW

There is often confusion surrounding the topic of public right-of-ways and utility easements. Please read below for some basic information on each

What is a city right-of-way? It is land dedicated to the city for public use and enjoyment. The size of a right-of-way depends on its location. Right-of-ways can be utilized by anyone at any time. Right-of-ways are typically found along public streets but may be located in other areas on your property.

What is a utility easement? Utility easements are specific areas on your property where utility companies (gas, water, sewer, electric, etc.) are authorized to enter on in order to install or maintain their infrastructure. The utility companies do NOT need your permission and are not required to notify you when accessing their easement. Easements are often run in conjunction with right-of-ways, but they may be located on other areas of your property.

Who maintains a city right-of-way? In accordance with Chapter 22, Section 16 of our city ordinances, the adjoining property owner is responsible for maintaining the right-of-way. This includes the grass, trees, shrubs, debris, etc. The city may, at its discretion, perform needed maintenance within its right-of-ways. The city is not required to seek permission from or notify the adjoining property owner of such maintenance.

Who maintains a utility easement? The property owner is responsible for maintaining utility easements. Some utility companies do perform certain types of maintenance (removal of limbs from electric lines, etc.). Please contact that specific utility company for more information.
